

Applicant Support Program (ASP):


Org submission closes 19 Nov. 2025. Application submission closes complete by 19 Dec



New gTLD Program: 2026 Round Application Submission Period: Expected to open April 2026 for 12-15 weeks.

Registry Service Provider (RSP) Evaluation Program

- Pre-Evaluation period opens 19 Nov. 2024; Closes 20 May 2025
- Another Evaluation period opens and closes during the gTLD application submission periods

2. Asks for ccTLDs in the region

- Participate in ccNSO discussions, share best practice.
 - Refer to ccNSO meetings archives
 - Update the IANA and the ccNSO records of staff POC
- What are ccTLD Registries doing to address Abuse?
- Use of AI to track / mitigate Abuse
 - Think about Disaster Recovery of the ccTLD
- Join the Domain Metrica initiative
 - The platform now provides ccTLD Operators with valuable insights into domain activity and DNS Abuse trends within their own TLDs.

3. Some initiatives

- Registration Data Request System (RDRS) extended for 2 years
 - Encourage use of RDRS
- New Step-by-Step Guide for Submitting DNS Abuse Complaints
- Technical Capacity Development
 - Reach out /request if your organization seeks training or tutorials on DNS Security and ICANN related topics
 - Consider in-person and/or Webinar format
- Host an anycast L-rootserver Instance
 - Send EOI to ICANN regional rep

4. How to Participate at ICANN
